## Subject: Liberty Utilities (CalPeco Electric) LLC (U 933-E) Compliance with Ordering Paragraph 8 of Decision 14-11-005

Pursuant to Ordering Paragraph 8 of Decision 14-11-005, Liberty Utilities (CalPeco Electric) LLC (U 933-E) ("Liberty Utilities") hereby submits the following authorized monthly budgets for the Energy Savings Assistance ("ESA") and California Alternate Rates for Energy ("CARE") Programs and the related bridge funding memorandum account balance.

#### <u>Purpose</u>

The purpose of this filing is to confirm Liberty Utilities' authorized monthly budgets for the ESA and CARE Programs and to show the difference between the revenue requirement adopted in Decision 14-11-005 and that requested in the applications beginning January 1, 2015.

#### **Request**

Liberty Utilities' monthly ESA and CARE budgets are \$16,735 and \$51,000, respectively. These amounts are the previously approved bridge funding amounts. Liberty Utilities has been able to maintain these budgeted amounts and has not recorded additional expenditures in the bridge funding memorandum account. As of October 31, 2014, the bridge funding memorandum account balance was zero dollars.
