

## **Hot Water Recirculating System Rebate Program**

## Rebate Information/Terms and Conditions

- 1. The rebate only applies to newly installed hot water recirculating systems.
- 2. The rebate amount is up to \$175 for each hot water recirculating system for up to two systems. Tax is not included.
- 3. Once you have purchased and installed your hot water recirculating system, please submit a completed, signed Rebate Request form, a copy of your original itemized receipt, a photo of the installed system, and a copy of your current water bill. Please keep a copy for your records. The required documents may be sent to Conservation@libertyutilities.com or mailed to our office 21760 Ottawa Rd., Apple Valley, CA 92308 addressed to Water Efficiency Department Rebate.
- Liberty will contact you once your paperwork has been reviewed and approved.
- **5.** A check may take 6-8 weeks to be processed and mailed.

## Eligibility

- 1. The hot water recirculating system must be purchased and installed between 5/1/2022 and 6/30/2023.
- 2. The property must receive water service from Liberty Utilities
- The Hot Water Recirculating System Rebate Program only applies to newly installed systems.

## **Program Terms**

- 1. Limit two rebates per household.
- 2. The hot water recirculating system may be installed by the homeowner or by a licensed plumber. Cost of installation is not covered as part of the rebate. Tenants must have approval from the property owner before install. Property owners must contact the water efficiency team to verify approval.
- **3.** Rebate does not include additional parts purchased for system and does not apply for water heaters.
- **4.** The completed Rebate Request form must be submitted with a photo of the installed system, a copy of your original receipt and a copy of your current water bill.
- **5.** Liberty reserves the right to conduct a site visit to confirm the recirculating system is being used.
