Dear Mr. Robinson:

Please be advised that the Division of Water and Audits (DWA) has approved Liberty Apple Valley's Advice Letter (AL) No. 216-A filed on March 02, 2016. Decision (D.) 15-11-030 authorizes Liberty Apple Valley to recover from customers the revenue under collection tracked in its Interim Rates Memorandum Account (IRMA) through a temporary 21.5-month surcharge. In approving AL 216-A, DWA is rejecting the Town of Apple Valley's protest.

AL 216-A requests amortization of the \$2,929,576 balance in the IRMA through a temporary 21.5-month surcharge of \$0.430/Ccf. effective March 25, 2016. Originally AL 216 filed on February 16, 2016 requested authorization to implement recovery of the balance of \$2,973,129 in the IRMA through a temporary 21-month surcharge of \$0.458/Ccf effective March 17, 2016.

Liberty Apple Valley's AL 216 and 216-A are designated as Tier 2 filings that become effective upon DWA's review in compliance with D.15-11-030.

The Town of Apple Valley (Town) filed a protest on March 7, 2016. The Town protested AL No. 216-A pursuant to General Rule 7.4.2 on the basis the requested relief is unjust, unreasonable and discriminatory.

Liberty Apple Valley corrected two errors in its initial calculations in AL 216 through filing a supplement, AL 216-A, that excluded uncollectible and franchise expenses in the calculation of the IRMA balance. DWA reviewed both the original filing, AL 216, and the revised supplement, AL 216-A, and approves the revision correcting the two errors discovered in Liberty Apple Valley's initial calculations. The revised surcharge is designed to recover the balance between what customers paid under interim rates during the period January 2105 – November 2015 period and what they would have paid had the Commission approved the final rates starting January 1, 2015.

Liberty Apple Valley will implement the surcharge on March 25, 2016 and will track the surcharge revenues to offset the amounts in IRMA. Any under or over collection will be reconciled in the future after the end of the 21.5-month surcharge period.



This supplemental filing is being made to incorporate comments from the Division of Water and Audits ("DWA"). This supplemental filing will replace Advice Letter 216-W in its entirety.

The purpose of this filing is to recover the difference between the interim rates established by Advice Letter 194-W, effective January 1, 2015 and Advice Letter 199-W-A, effective June 1, 2015 and the final rates established by Advice Letter 204-W, effective November 24, 2015 in compliance with Decision 15-11-030.

Background and Discussion

These tariffs are submitted as authorized by Decision 15-11-030, Ordering Paragraph No. 4:

Within sixty days of the adoption of this decision, Apple Valley Ranchos Water Company (AVR) is authorized to file a Tier 2 Advice Letter to recover the difference between the interim rates and final rates from its customers in all districts. The difference between the interim and final rates based on the revenue requirement adopted here, shall be recovered over the balance of the rate case cycle.

The new rates authorized by Decision 15-11-030 became effective on November 24, 2015. Liberty Apple Valley bills on a bi-monthly basis, and as a result, all bills including some at the interim rate, were not issued until January 23, 2016. Liberty Apple Valley did

not have the necessary billing information until 60 days after the effective date of the rate change; and furthermore needed to calculate the final balance in the Interim Rates Memorandum Account, and the surcharge to amortize the balance. Accordingly, Liberty Apple Valley requested a 4-week extension until February 15, 2016 to comply with Ordering Paragraph No. 4 of Decision 15-11-030. On January 19, 2016, the Executive Director of the California Public Utilities Commission ("Commission") granted Liberty Apple Valley's request.

Liberty Apple Valley has determined the difference between the rates authorized by Decision 15-11-030 and the interim rates authorized by the Commission for the period January 1, 2015 through November 23, 2015. The total revenue shortfall is calculated using recorded customer and usage consumption for that period. For the domestic system, the total calculated revenue shortfall is \$2,918,599. With interest through January 31, 2016 the total under-collected balance is \$2,922,579. The total revenue to be recovered is \$2,922,579 or approximately 12.73% of Liberty Apple Valley's 2016 adopted revenue requirements. For the irrigation system, the total revenue calculated was \$6,986. With interest through January 31, 2016 the total shortfall is \$6,997. The total revenue to be recovered is \$6,997 or approximately 3.23% of the irrigation system's 2016 adopted revenue requirements. The total combined revenue to be recovered for both the domestic and irrigation system is \$2,929,576 or approximately 12.64% of its 2016 adopted revenue requirements.

Liberty Apple Valley is requesting to recover the shortfall of \$2,929,576 until the balance is fully amortized as stated in Ordering Paragraph No. 4. Liberty Apple Valley is proposing a 21.5-month surcharge of \$0.430 per Ccf for domestic service for Schedule No. 1, Residential General Metered Service, and Schedule No. 3, Non-Residential General Metered Service, \$0.009 per Ccf for Schedule No. 2, Gravity Irrigation Service, and \$9.16 per month for Schedule No. 4, Non-Metered Fire Service.

The Commission Staff has been provided with workpapers showing the derivation of the surcharges and interest.

Tier Designation

Pursuant to D.15-11-030, this advice letter is submitted with Tier 2 Designation.

Effective Date

Pursuant to General Rule 7.3.2 of General Order 96-B, Liberty Apple Valley requests this filing become effective on March 25, 2016.



For the irrigation system, the total revenue calculated was \$6,883. With interest through January 31, 2016 the total shortfall is \$6,894. The increase in revenues would generate an increase of \$101 in uncollectible and franchise expense. The total revenue to be recovered is \$6,995 or approximately 3.18% of the irrigation system's 2016 adopted revenue requirements.

Liberty Apple Valley is requesting to recover the shortfall of \$2,973,129 until the balance is fully amortized as stated in Ordering Paragraph No. 4. Liberty Apple Valley is proposing a 21-month surcharge of \$0.458 per Ccf for domestic service for Schedule No. 1, Residential General Metered Service, and Schedule No. 3, Non-Residential General Metered Service, \$0.009 per Ccf for Schedule No. 2, Gravity Irrigation Service, and \$9.78 per month for Schedule No. 4, Non-Metered Fire Service.
