REDUCE ENERGY AND SAVE MONEY THIS WINTER

Winter is the time Liberty Utilities customers consume the most energy. That can mean higher bills, but it's also an opportunity to take some simple, no-cost steps to reduce your winter usage and, as a result, save 10-25% on your energy costs.

- Set your thermostat to 68 degrees when home, and then back to 55-68 degrees when unoccupied.
- Open window coverings on the sunny side of your home to take advantage of free heat from the sun.
- Close foundation vents.
- Turn off lights and appliances when not in use; including your computer.
- Use your dishwasher, clothes washer & dryer and cook as late in the evening as possible.
- Vacuum your refrigerator coils, underneath and in the back.

KEEP YOUR METERS CLEAR FROM SNOW

During the winter months, Liberty Utilities asks for your help in keeping snow cleared around your meters so it can be read by our meter readers. If you own a non-primary resident (i.e., a second home), you may qualify for our Zero Estimated Billing where you are billed at zero energy usage only during those winter months until we can access your meter in the Spring.

RELIABILITY IMPROVEMENT UPDATE

Customers tell us that reliability is their top priority. Since acquiring the utility service territory in 2011, Liberty Utilities has planned for and completed several projects designed to improve reliability of your electric service. Here's an update on just two of them.

7203 Electric Line Improvement Project

Liberty replaced a 1.1 mile section of its 14.4 kilovolt power line known as the 7203 Distribution Line which lies within the Town of Truckee. ***The existing distribution wire on this portion of the line was replaced with larger-diameter wire to maintain safe and reliable delivery of electric service.*** The improvement enables approximately five megawatts (5 MW) of additional load to be fed from that line to help meet anticipated peak energy demand during this coming winter. The project began on August 29, 2014 and was completed in early October, 2014.

625/650 Electric Lines Upgrade Project

These major transmission lines serve the North Tahoe area. ***The \$46 million project will improve reliability, even if a portion of the closed loop system is damaged, by allowing greater load transfer and switching ability that benefits the entire system.***

The final environmental document was issued by the U.S. Forest Service, the California Public Utilities Commission, and the Tahoe Regional Planning Agency on September 19, 2014. Phase 1 construction (rebuilding of the 650 line between Martis and Kings Beach) will begin once permits are obtained with anticipated completion in 2015.

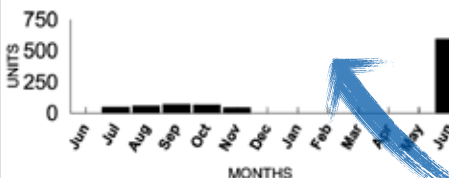
