Advice Letter 156-E (U 933-E)

Subject: Liberty CalPeco's Transportation Electrification Pilot Programs for Schools and Parks Site Assessments

Purpose

Pursuant to Commission Decision ("D.") 19-11-017, and Assembly Bills (AB) 1082 and 1083, Liberty Utilities (CalPeco Electric) LLC (U 933 E) ("Liberty CalPeco") is submitting this Tier 2 advice letter to provide an update on site assessments and costs associated with Liberty CalPeco's transportation electrification ("TE") pilots to deploy electric vehicle charging infrastructure at California schools, state parks, and beaches.

Background

Ordering Paragraph 24 of D.19-11-017 directs parties to file a Tier 2 Advice Letter to provide an update to pilot implementation programs with the following requirements:

- 1. Identify the number of sites the utility performed a site-assessment;
- 2. Identify the costs to install the charging infrastructure at the sites where the utility performed a site-assessment;
- 3. Include the number of outstanding site-assessments the utility needs to perform; and
- 4. Provide a revised pilot-wide port forecast based on the utility's performed site-assessments.

Liberty CalPeco's AB 1082 TE Pilot Site Assessments

Liberty CalPeco has performed site assessments for two of the 17 sites identified for participation in the pilot. The Lake Tahoe Unified School District ("LTUSD") project includes eight level-2 charging ports with an estimated cost of \$633,291. The Lake Tahoe Community College ("LTCC") project will deploy four level-2 ports and two Direct Current Fast Charger ("DCFC") ports with a forecast project cost of \$604,500. There are 15 outstanding site assessments to be performed in Liberty CalPeco's service territory for the AB 1082 pilot. The pilot-wide forecast has been revised from a total of 56 level-2 and two DCFC ports to 48 level-2 and two DCFC ports.

AB 1083 TE Pilot Site Assessments

Liberty CalPeco has not performed any site assessments for the AB 1083 pilot. Challenges to implementing the pilot include internal resource constraints related to staffing, and slow response time from external parties related to COVID-19. There are three site assessments outstanding in the pilot for parks and beaches. Since there are no revisions based on site assessments for this pilot, the cost forecast remains at \$741,000 for 10 level-2 charging ports at the three outstanding locations.

Tier Designation

Pursuant to General Order 96-B, Section 5, this Advice Letter is being submitted with a Tier 2 designation.

Effective Date

Liberty CalPeco requests that this **Tier 2** Advice Letter be effective as of November 7, 2020.
