Subject: Liberty Utilities (CalPeco Electric) LLC (U 933-E) – Rule 20A Work Credits

Purpose

Pursuant to Ordering Paragraph ("OP") 5 of California Public Utilities Commission ("Commission") Decision ("D.") 23-06-008, Liberty Utilities (CalPeco Electric) LLC (U 933-E) ("Liberty") submits this **Tier 1** Advice Letter ("AL") to notify the Commission that Liberty does not intend to make any reallocations of Electric Rule 20A work credits.

Background

In OP 5 of D.23-06-008, the CPUC ordered:

Pacific Gas and Electric Company, Southern California Edison Company, San Diego Gas & Electric Company, Bear Valley Electric Service Company, Liberty Utilities, and PacifiCorp shall each file a Tier 2 advice letter within 18 months of the effective date of this decision to propose reallocations of Electric Rule 20A work credits in accordance with Ordering Paragraph 4. If a utility does not intend to make any reallocations of Electric Rule 20A work credits, the utility may file a Tier 1 advice letter to notify the Commission that it will not make any reallocations of work credits during the remainder of the Electric Rule 20A program.

Rule 20A Work Credits

On February 7, 2022, Liberty submitted information on its list of Electric Rule 20A Active and Inactive Communities in California pursuant to Decision 21-06-013 Ordering Paragraph 3(b) and 3(c).

Effective Date

Liberty requests that this Tier 1 advice letter be effective as of December 3, 2024.

Protests

Anyone wishing to protest this advice letter may do so by letter sent via U.S. mail, facsimile, or email, any of which must be received no later than December 23, 2024, which is 20 days after
