I. <u>Purpose</u>

Liberty Utilities (CalPeco Electric) LLC (U 933 E) ("Liberty CalPeco") hereby submits this Tier 2 Advice Letter No. 104-E to establish an Emergency Customer Protections Memorandum Account (ECPMA) in compliance with Commission Decision (D.) 18-08-004 ordering paragraph 3.

II. Discussion

On August 9, 2018, the Commission adopted D.18-08-004 (Decision) extending the emergency customer protections adopted in Resolution M-4833 and Resolution M-4835 to customers of all investor-owned utilities. Pursuant to the Decision, Liberty CalPeco's Emergency Customer Protection Plan is available to residential and small business customers in areas where a state of emergency proclamation is issued by the Governor of California where the disaster has either resulted in the loss or disruption of the delivery or receipt of utility service, and/or resulted in the degradation of the quality of utility service. Liberty CalPeco's Emergency Customer Protection Plan is extended to eligible customers in the affected disaster area for a period of one year commencing from the date the state of emergency proclamation was issued, or until Liberty CalPeco service is restored.

Pursuant to ordering paragraph 3 of the Decision, Liberty CalPeco files this advice letter to establish the Emergency Customer Protections Memorandum Account (ECPMA).

Tier Designation

Pursuant to ordering paragraph 3 of D.18-08-004, this advice letter is being submitted with a Tier 2 designation.

Effective Date

Liberty CalPeco requests that this Tier 2 Advice Letter become effective on October 10, 2018.

Protests

Anyone wishing to protest this Advice Letter may do so by letter sent via U.S. mail, by facsimile or by email, any of which must be received no later than October 1, 2018. There are no restrictions on who may submit a protest, but the protest shall set forth the grounds upon which it is based and shall be submitted expeditiously. Protests should be mailed to:

The emergency customer protections and the ECPMA will remain in effect for one year following the proclamation of a state of emergency, or until utility service is restored, to record costs related to the state of emergency declared by the Governor of the State of California.
