<u>Victims</u>

Liberty Utilities (CalPeco Electric) LLC (U 933 E) ("Liberty CalPeco") hereby submits this **Tier 2** Advice Letter No. 82-E in response to the California Public Utilities Commission's ("Commission") Resolution M-4833 ("Resolution"), which implements emergency consumer protections to support residential customers impacted by the October 2017 wildfires.

Purpose

The purpose of this filing is to notify the Commission that no Liberty CalPeco customers were impacted by the October 2017 wildfires and, as such, no Liberty CalPeco customers would be eligible for the consumer protections ordered in the Resolution. Accordingly, Liberty CalPeco does not propose any changes to its tariffs.

Background

Beginning on October 8, 2017, a series of wildfires broke out throughout California affecting residents in the following California counties: Butte, Lake, Mendocino, Napa, Nevada, Orange, Solano, Sonoma, and Yuba. In response to Governor Edmund G. Brown's proclamation of a state of emergency due to the fires, the Commission issued the Resolution on November 9, 2017. The Resolution includes requirements for many investor-owned utilities subject to the Commission's jurisdiction, including Liberty CalPeco, to implement various emergency consumer protections to support the victims of the wildfires.

Discussion

Liberty CalPeco provides electricity to approximately 49,000 customers in portions of seven counties around Lake Tahoe. Of the counties listed above and in the Resolution, only Nevada County is located in Liberty CalPeco's service territory. Liberty CalPeco only serves a small part of the Eastern portion of the county around the Truckee area, where Liberty CalPeco has 1,311 customers. Records from CalFire show only three relatively small wildfires occurring in Nevada County in October 2017, and all three fires were located in the Western portion of the county,

which is served by PG&E. Accordingly, no Liberty CalPeco customers were directly impacted by the October 2017 wildfires and no Liberty CalPeco customers would qualify for the consumer protections ordered in the Resolution.

The following maps show the location of the fires in Nevada County in October 2017 and Liberty CalPeco's service territory in Nevada County.
