

Park Water Company (U 314 W) ("Park") hereby transmits the following revised tariff sheets applicable to water service in its service territory:

On December 28, 2015, the Commission issued Decision 15-12-029 approving Application 14-11-013, and authorizing the merger of Liberty WWH, Inc. with and into Western Water Holdings, LLC. The merger was completed on January 8, 2016. As a result of the merger, Liberty Utilities Co. is now an upstream owner of Park and Apple Valley Ranchos Water Company. Pursuant to Decision 15-12-029, on January 12, 2016 Park notified the California Secretary of State that it was changing its name to Liberty Utilities (Park Water) Corp.. This change in name became effective January 12, 2016. From that date forward, all documents submitted to the Commission will be under the "Liberty Utilities (Park Water) Corp." name. The only changes being made at this time are the name change and the name/title of the individual authorized by the Company to legally obligate it.

The purpose of this advice letter filing is to notify the Commission that all of its tariffs, rules, notices, concurrences, provisions, authorities, powers of attorney or whatsoever other instruments that are on file with the Commission will be converted to the new "Liberty Utilities (Park Water) Corp." name.

To initiate this name change, Park is submitting a revised Title Page to its tariff book with this advice letter. The revised Title Page is being submitted as the first step in converting all of Park's tariffs to the new Liberty Utilities (Park Water) Corp. name. The remaining tariffs will be changed over time, either in subsequent advice letter filings, or as changes are made to each individual tariff page.

Notice and Service

In accordance with General Order 96-B, General Rule 4.3 and 7.2 and Water Industry Rule 4.1, a copy of this advice letter will be mailed or electronically transmitted on January 14, 2016 to competing and adjacent utilities and other utilities or interested parties having requested such notification.

Response or Protest

Anyone may respond to or protest this advice letter. When submitting a response or protest, please include the utility name and advice letter number in the subject line. A response supports the filing and may contain information that proves useful to the Commission in evaluating the advice letter. A protest objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. A protest shall provide citations or proofs where available to allow Staff to properly consider the protest. The grounds for a protest are:

- 1. The utility did not properly serve or give notice of the advice letter;
- 2. The relief requested in the advice letter would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;
- 3. The analysis, calculations, or data in the advice letter contain material error or omissions;

- 4. The relief requested in the advice letter is pending before the Commission in a formal proceeding; or
- 5. The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
- 6. The relief requested in the advice letter is unjust, unreasonable, or discriminatory (provided that such a protest may not be made where it would require relitigating a prior order of the Commission.)

A response or protest must be made in writing or by electronic mail and must be received by the Division of Water and Audits within 20 days of the date this advice letter is filed. The address for mailing or delivering a protest is:
