

#### Summary

Liberty Park Water submits this advice letter to update the eligibility income guidelines in its rate assistance program for low-income customers, also known as the California Alternative Rates for Water ("CARW") program. The CARW eligibility guidelines are patterned after the guidelines established in the California Alternate Rates for Energy ("CARE") program for energy utilities. When approved, this filing will increase the eligibility income levels in Liberty Park Water's CARW program to match the eligibility income guidelines in the energy utilities CARE program. Liberty Park Water is also modifying the description of the CARW program contained in the Preliminary Statement.

## Background

On October 19, 2006, the California Public Utilities Commission ("Commission") issued Decision 06-10-036 granting Liberty Park Water authority to establish its CARW program. The CARW program consists of a \$7.06 per month service charge discount for customers who meet income eligibility requirements. The eligibility income guidelines are revised annually by the Commission and are effective each June 1<sup>st</sup>. On March 2, 2016, the Commission established the 2016/2017 eligibility income guidelines, effective June 1, 2016. This advice letter is being filed to reflect the updated eligibility income guidelines on Liberty Park Water's CARW tariffs.

## **Compliance**

Liberty Park Water has revised its Form No. 13 to reflect the annual increase to eligibility income. The table below shows the increase to each level of the eligibility income.

## **Requested Effective Date**

Pursuant to Resolution E-3524 adopted February 19, 1998, Liberty Park Water respectfully requests approval of this advice letter allowing these tariffs to become effective June 1, 2016.

## **Notice and Service**

This advice letter does not seek to increase any rate or charge. Therefore, customer notice is unnecessary. In accordance with General Order 96-B, General Rule 4.3 and 7.2 and Water Industry Rule 4.1, a copy of this advice letter will be mailed or electronically transmitted on May 25, 2016 to competing and adjacent utilities and other utilities or interested parties.

## **Response or Protest**

Anyone may respond to or protest this advice letter. When submitting a response or protest, please include the utility name and advice letter number in the subject line. A response supports the filing and may contain information that proves useful to the Commission in evaluating the advice letter. A protest objects to the advice letter in whole or in part and must set forth the specific grounds on which it is based. These grounds are:

- (1) The utility did not properly serve or give notice of the advice letter;
- (2) The relief requested in the advice letter would violate statute or Commission order, or is not authorized by statute or Commission order on which the utility relies;

- (3) The analysis, calculations, or data in the advice letter contain material error or omissions;
- (4) The relief requested in the advice letter is pending before the Commission in a formal proceeding; or
- (5) The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
- (6) The relief requested in the advice letter is unjust, unreasonable, or discriminatory (provided that such a protest may not be made where it would require relitigating a prior order of the Commission.)

A protest shall provide citations or proofs where available to allow Staff to properly consider the protest. A response or protest must be made in writing or by electronic mail and must be received by the Division of Water and Audits within 20 days of the date this advice letter is filed. G. California Alternative Rates for Water (CARW) Revenue Reallocation Balancing Account

- <u>Purpose</u>: The purpose of the CARW Revenue Reallocation Balancing Account is to track the recorded discounts provided through Schedule No. CARW and the recordable surcharge (T) collected through Schedule No. CARW-SC. The authority to establish this account was granted in CPUC Decision 06-10-036 dated October 19, 2006, and in Public Utilities Code Section (T) 739.8. This account will be in existence until sufficient experience with the CARW program is attained such that estimates of participation levels can be reliably forecast in a general rate case proceeding. This account will terminate when so ordered in a CPUC general rate case decision, at which time any remaining debit (under collection) or credit (over collection) balance will be amortized through a rate surcharge or surcredit.
- 2. <u>Accounting Procedure:</u> The following entries will be made monthly to the CARW Revenue Reallocation Balancing Account:
  - a. The recorded reduction in billed Service Charge revenues for service provided under Schedule No. CARW (debit).
  - b. The recorded surcharge revenues for service provided under Schedule No. 1 authorized to fund the CARW Program (credit).
  - Monthly interest expense calculated at 1/12 of the most recent month's interest rate on Commercial Paper (prime,3-month), published in the Federal Reserve Statistical Release, H.15 <u>http://www.federalreserve.gov/Releases/H15/data/Annual/H15\_NCFP\_M3.txt</u> or its successor publication (debit or credit).


