## Why am I receiving this notice?

On May 1, 2023, Liberty Apple Valley filed its cost of capital application (A.23-05-004) with the CPUC. The application is requesting a total increase of \$987,700.

If the CPUC approves this application, Liberty Apple Valley will recover forecasted costs in rates over a three-year period beginning July 1, 2024. This will increase your bill.

## Why is Liberty Apple Valley requesting this rate increase?

The CPUC requires Liberty Apple Valley to file a cost of capital application every three years. The cost of capital determines the amount of money Liberty Apple Valley is allowed to recover in rates as a return on the funds it has invested in utility infrastructure used in providing water service.

## How could this affect my water bill?

If Liberty Apple Valley's rate request is approved by the CPUC, the average residential bill with a 5/8" x 3/4" meter using 11.95 CCF (CCF is one hundred cubic feet or 748 gallons) per month would increase by approximately \$2.79 or 3.31% per month, from July 1, 2024, through June 30, 2027. The table below excludes applicable taxes and surcharges.

### How does the rest of this process work?

This application has been assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt Liberty Apple Valley's application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding will review Liberty Apple Valley's application, including the Public Advocates Office, which is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels.
