NOTICE OF PROPOSED PURCHASE OF THE CITY OF PERRIS MUNICIPAL WATER SYSTEMS BY LIBERTY UTILITIES (PARK WATER) CORP. APPLICATION NO.18-05-011

Dear City of Perris Water Customer:

On May 9, 2018, Liberty Utilities (Park Water) Corp. (Liberty Park Water) filed Application No. 18-05-011 with the California Public Utilities Commission (CPUC) requesting authority to purchase the City of Perris's Municipal Water Systems (Perris MWS). The proposed sale is valued at \$11,500,000. The Perris MWS are currently in debt. Each year more money is spent operating the water system than the amount that is collected from customers. The City of Perris (City) General Fund pays for these deficits, which means there is less money for public services benefiting all City residents.

Liberty Park Water's application is also requesting an interim rate plan for Perris customers during the first 10 years after the sale (Perris Interim Rate Plan). After the sale is completed, rates would be adjusted to the rates in effect for the Eastern Municipal Water District (EMWD)¹. Under the interim rate plan, rates can be adjusted each year to match any increase by EMWD or 3.3%, whichever is greater. Future rates are also subject to changes in the supply mix necessary to reliably serve customers or changes in purchased water rates. The Perris Interim Rate Plan is designed so all water service provided within the City is similarly priced. When the Perris Interim Rate Plan ends, rates will be set by the CPUC in a future Liberty Park Water General Rate Case. Tables 1A and 1B show the rates proposed by the Perris Interim Rate Plan.

CPUC PROCESS

This application has been assigned to an Administrative Law Judge (Judge) who will determine how to receive evidence and other related documents, necessary for the CPUC to establish a record upon which to base its decision. Evidentiary hearings may be held where parties of record will present their testimony and may be subject to cross-examination before the Judge. These hearings are open to the public, but only those who are parties of record may present evidence or cross-examine witnesses. After considering all proposals and all evidence presented during the formal hearing process, the Judge will issue a draft decision which may adopt all or part of Liberty Park Water's request, modify, or deny the application. Any of the five CPUC Commissioners may sponsor an alternate decision and the issue will be voted on at a scheduled CPUC Voting Meeting.

The Office of Ratepayer Advocates (ORA) has reviewed this application. ORA is the independent consumer advocate within the CPUC with a legislative mandate to represent investor-owned utility customers.
